\*A quick definition of an Endowment Fund governed by the State of Iowa: It is a fund established for a specific purpose where 5% of the value of the fund by law can be withdrawn yearly to fund a project. The remainder of the yearly interest over 5% remains for growth of the fund and years when the fund makes less than 5%, the draw would be on principle. The fund manager (**to be determined**) in consultation with the MMCI representative would be responsible for selecting how to invest the fund money and will be accountable to the MMCI Board of Directors.
